The question of whether other issues will be jeopardised by the lack of Parish Council funds will not be known until a cashflow forecast has been drawn up.

The Chairman explained that the Parish Council was not holding up the progress on the building of the new village hall.

Chairman S Clarke left the room while it was agreed that the cheque to Mr R A Clarke be signed by the Vice Chairman A Lambard.

Clerk reported that bank mandate for change of signatures was completed on the 22nd June.

8. Parish Council Property Reports

(a) Staithe

- 1. Mr Reading had left a message that he will pay the outstanding rent for dry berth 53 in early August. A deadline of the 7th August was agreed and the Chairman will monitor progress.
- 2. The Staithe Warden H Nudd notified the Parish Council about the state of the wire on the slipways and the pegs for dry berths require attention.
- 3. Winches are in need of repair.

It was agreed for the Staithe Working party to arrange a site visit to thoroughly investigate all conditions at the staithe and report back to the next Parish Council meeting or before if deemed necessary.

(b) Chapel Pit

- 1. One of the willow trees overhanging the bottle banks was reported to have a crack in one of the large branches which was potentially dangerous, so the tree surgeon has trimmed the tree accordingly. These to be added to the yearly property walks for continued maintenance.
- 2. The bottle banks collections have been reviewed and the Council has requested another 'white glass' bank but this will take time.

9. Footpath map

The information boards were agreed on, noting the spelling of 'Domesday', the Clerk or Chairman will contact the footpath ranger for the boards to be erected.

10. Mower Repair

This is still under discussion. The invoices supplied are not sufficient for John Deere to honour the warranty, but the Chairman will continue to pursue the matter but it was agreed for the mower to be repaired forthwith. The overall grass cutting issue to be re-visited

11. Charity/Parish Council update

- **13.** Parish Surgeries- Cllr D Scott will hold surgeries in the Methodist Hall, at no cost, on the 3rd Thursday of every month for the next 3 months then the issue will be revisited.

Post Office/Shop – The parish council agreed for Vice Chairman A Lambard to further investigate this idea and report back to the Parish Council in due course.

14. Homewatch Co-ordinator –Cllr T Ellis offered to look into this in conjunction with the Resilience Workshop that she is attending.

It was bought to the Council's attention that two hedges in the village require attention, Little Orchard, Heath Road & Chapel Road near the village sign. Clerk to follow up.

County Councillor Paul Rice spoke about a site meeting he has arranged with Highways Officer P Riley regarding speeding and lorries on Stubb Road leading to the NWT. A new traffic sign indicating a children's play area to be erected on Ouse Lane. He is now a Coast Guard Rescue Officer and will be asking for support to stop the closure of the Great Yarmouth site.
